Sub: Cancellation of contracts / NOC and forfeiture of security amount & caution money on account of non-payment of dues.

Dear Sirs,

Kindly refer to this office show cause notice dated 26.12.2011 followed by final show cause notice dated 06.01.2012 and letter dated 02.03.2012, on the subject cited above. Despite the opportunities granted and the assurances given by you from time to time, you failed to clear the dues or submit a satisfactory explanation for non deposit of dues. As on date, a total amount of Rs. 76,33,664/- is outstanding against you on account of arrears of licence fee, advertisement tax and penalty on delayed payments.

In view of this, competent authority has ordered to cancel all the following contracts / NOC granted to you for display of advertisement through unipoles / Building wrap and forfeit the security amount and caution money deposited by you at the time of grant of contracts / NOC:-


Further, the competent authority has also rejected your request for restoration of the following contracts which stand already cancelled:-

You are also called upon to deposit the dues of **Rs. 76,33,664/- within seven days from the date of issue of this letter**, falling which action for recovery of the same will be initiated without any further communication to you.
